Overage Permits

- Re correspondence 26/03/17 – Overage Permit request – Blayre Smith (CDHBU FNC)
- Re correspondence 28/03/17 – Overage Permit – Dougal Robb. Resubmission of Overage Permit Request for U14s (CDHBU FNC). Additional supporting documentation was considered by the Board.
- **Motion:** Blayre Smith and Dougal Robb Overage Permit requests be approved by the League. Moved B.I'Anson. 2nd A.Dore. Carried.
- Discussion regarding 3 Overage Permits allowed for CDHBU U14s in relation to recommendation from CMC Minutes 11/06/2014 to allow only 2 AO permits per team.
- **Motion:** CDHBU U14s Overage Permits be restricted to 2 per game in 2017 unless the opposition has greater playing numbers than CDHBU U14s on match day or the opposition approves otherwise. Moved P.Beesley. 2nd P.Bouffler. Carried.
- Approved Overage Permit requests are constantly reviewed by the committee throughout the year and may be overturned. Permits that were rejected due to permit age limitation above can be reconsidered on request from clubs supported by addition documentation.

General Business

- Re Correspondence 10/04/17 – Riverina Vintage Machinery Club. Request from Ken Hall for League to donate to Beyond Blue and Prostate cancer research. The Board acknowledged the cause but decided to decline the request.
- B'Ianson briefed the Board of possible candidates for the 2017 Hall of Fame. Candidates to be confirmed at next Hall of Fame sub-committee meeting.
- D.Wegener advised the number of Player Point submissions being forwarded to the League Equalisation Panel for possible reduction and the process involved as defined within the AFL NSW/ACT/HFNL Player Points System Policy located on the HFNL website. D.Wegener raised query in concern to the validity of some Leagues listed as a Premier Competition within the Policy. The Board agreed to conform to current listing as stated in AFLVIC Points Policy.
- Phil Bouffler and Merv Wegener still actively seeking new sponsors for the League with Elastoplast a possibility for 2018.
- D.Wegener advised of non-attendance from Culcairn FC at Tribunal Hearing 18th April. **Motion:** Culcairn FC to be fined as per HFL Condition under By-Law 26.10 (A) Tribunal Hearings. Moved P.Beesley. 2nd J.Clancy. Carried.
- D.Wegener reported the number of Headsmart Baseline Screenings so far completed by each club. Only 359 players across the League have successfully completed the test.

- B.I'Anson discussed the terms of the 33 month General Manager contract agreement for D.Wegener. Suggestion to have a possible tender process involving the advertisement of the position. **Motion:** General Manager Contract Agreement for D.Wegener is accepted by the HFNL Board. Moved B.I'Anson. 2nd P.Beasley. Carried (7-2).
- D.Wegener briefed Board regarding the proposed bank account setup of both football and netball financials under the amalgamated entity.
