President's Report

- Pleased with the outcome of Finals month overall.
- Positive feedback regarding VACK Security during the finals. Discussion re proposed 2018 finals and the possible starting times of Security personnel.
- 2018 preliminary Interleague schedule discussion ongoing with Tallangatta and possibly Farrar League and O&K League.
- Discussion regarding procedure to elect Life Members at the AGM. General Manager to issue notice as per Constitution.
- Merv advised he will not be nominating for re-election to the Board at the AGM but will continue helping in some operational areas such as Interleague.
- Disappointed with the reaction from Culcairn FC in regards to the Tim Haines Report 27/08/17 and concerned the club may have brought the game into disrepute. The Board discussed events surrounding matter and the AFL Code of Conduct. In reference to the events pertaining to the Tim Haines Report, the Board resolved to refer the matter to the League's Independent Investigation Officer to investigate possibility the Culcairn FC was in breach of the AFL Code of Conduct.

2017 Finals Review

- General Manager briefed Board regarding operational matters during the Finals. Following conclusions were noted:
 - Roped off Interchange area was deemed a success and thanked clubs for their co-operation.
 - Thanked Al Collins for his work setting up camera cage for Travis Cartwright who supplied positive feedback.
 - Introduction of large Safe at the ground ensured more effective money handling.
 - Playing surface and outer ground in excellent condition. General Manager to consult with Grounds committee to formulate a maintenance schedule preceding the finals.
 - Possibility of schedule for Security personnel to start earlier in 2018.
 - NBN Satellite Internet service was installed for the Grand Final and worked well.
 - Electronic Scoreboard well received. More work to be done in 2018 to attract more sponsors on the day.
- Very positive feedback regarding the performance of Amie Riley singing the National Anthem.
- L.Gooden noted Netballers would like National Anthem to be performed at an earlier time. Discussion regarding the scheduled football starting times as there was often a large time gap between games.
